Pricing Guide/ Fee Agreement:

- **Individual Session Rate**
 - 53 - 60 minutes \$200.00
- **Couple Session Rate**
 - 53 - 60 minutes \$260.00
- **Family Session Rate**
 - 53 - 60 minutes \$290.00
 - *As a courtesy, private pay family sessions involving fewer than three members will be billed under the listed couple therapy rate.*

Insurance eligible Couple and Family Sessions

Couple Sessions \$60.00 + Copay

Family Sessions \$90.00 + Copay

- **Clients that no-show or cancel/reschedule with less than 24-hour notice will be charged the FULL private rate of the missed appointment. Three consecutive no-shows could lead to a discharge from services.**
- **Clients that arrive to their appointment after the session start time, not to exceed 15 minutes, will be charged a \$10 late fee. Tardiness of 15 minutes or more will result in a no-show cancellation.**
- **Appointment overages fees will be applied to each applicable session as follows:**
 - < 15 minutes \$25.00
 - 16 - 30 minutes \$50.00
 - 31 - 45 minutes \$75.00
 - 46 - 60 minutes \$100.00

INSURANCE

AETNA, UHC (United Health Care), UMR & Anthem BCBS, Medical Mutual, Carenton Behavioral Health, Cigna and Evernorth, MultiPlan, Optum, Oscar Health, Oxford along with select EAP providers are currently accepted for individual clients, however due to insurance billing policies a supplemental fee ranging from \$60-\$90 will be applied to individual insurance clients interested in engaging in couple or family therapy services. This supplemental fee, as well as appointment overages, late fees, etc. do not qualify toward your insurance deductible. This supplemental fee is not applicable to private pay (out-of-pocket) clients. We also provide

documents (i.e. Superbills) to assist with monthly client reimbursement for out-of-network private pay clients. If your insurance company provides out-of-network reimbursement benefits, you could be reimbursed for some or all of your upfront private pay session costs.

- **IMPORTANT NOTE:** Government Funded Health Plans are not currently accepted individually or as extensions of commercial insurances. Please verify the specifics of your benefits, co-pay, coinsurance, deductible, and reimbursement rate with your insurance provider before scheduling.
